


1. Call meeting to order

This process involves trained personnel to conduct an assessment on a suspected impaired individual. Following the assessment, the nurse will review documentation and communicate assessment findings with the administrator and state whether or not the student is "safe for school" or "not safe for school".
5. Carissa Munoz, M.S Texas A & M AgriLife Extension Service discussed and reviewed community health and safety programs. Discussed that she is now the nutrition educator for Carrizo Springs. Some topics that she may discuss including budget management, hypertension, Diabetes Mellitus, Mental Health, Childcare, postpartum and other various topics. 
