School Goals

4th Grade:

Math: Reporting Category 2: Computations and Algebraic Relationships: The student will demonstrate an understanding of how to perform operations and represent algebraic relationships.
CSI will increase from 50% to a 55% for the 2020-2021 school year.

Reading: Reporting Category 3: Understanding and analysis of informational text.3. Inquiry and research: listening, speaking, reading, writing, and thinking using multiple texts. The student engages in both short-term and sustained recursive inquiry processes for a variety of purposes. The student is expected to: (C) identify and gather relevant information from a variety of sources;13D

4th Grade ELAR will increase from a 41% to a 51% for the 2020-2021 school year.

5th grade:

Math: Reporting Category 2: Computations and Algebraic Relationships: The student will demonstrate an understanding of how to perform operations and represent algebraic relationships.

CSI will increase from 60% to a 65% for the 2020-2021 school year.

Reading: Reporting Category 3: Understanding and Analysis of Informational Texts. 4.8 Multiple genres: listening, speaking, reading, writing, and thinking using multiple texts--literary elements. The student recognizes and analyzes literary elements within and across increasingly complex traditional, contemporary, classical, and diverse literary texts. The student is expected to: (A) infer basic themes supported by text evidence;

5th Grade ELAR will increase from a 36% to a 50% for the 2020- 2021 school year.

Science: Reporting Category 3: Earth and Space **CSI will increase from a 57% to a 62% for the 2020-2021 school year.**

6th grade:

Math: Reporting Category 2: Computations and Algebraic Relationship: The student will demonstrate an understanding of how to perform operations and represent algebraic relationships. **CSI will increase from 63% to a 68% for the 2020-2021 school year.**

Reading: Reporting Category 3: Understanding and Analysis of Informational Texts. 5.9 Diii recognize characteristics and structures of informational text, including: organizational patterns such as logical order and order of importance;

6th Grade ELAR will increase from 35% to a 50% for the 2020-2021 school year.

4. - Conducting an annual Title I, Part A Parent Meeting within the 1st six weeks of school to inform parents of the district's participation in Title I, Part A, its requirements and their right to be involved.
- Parents are informed of the Title 1 Part A at the yearly meeting. (This meeting will occur on Tuesday, September 29, 2020, from 5:30- 6:15 P.M. & on Monday, October 5th from 6:00-6:45 P.M.
