District Title 1 Parental Involvement Policy**

Statement of Purpose

The CSJH will involve the parents of the children served in Title 1, Part A schools' decisions about how the 1 percent of Title 1, Part A funds reserved for parental involvement is spent and will ensure that not less than 90% of the one percent goes directly to the school.

CSJH will increase from a 54% to a 59% for the 2019-2020 school year.

CSJH will increase from a 55% to a 60% for the 2019-2020 school year.

8th grade:

Math: 8.3C use an algebraic representation to explain the effect of a given positive rational scale factor applied to two dimensional figures on a coordinate plane with the origin as the center of dilation.

CSJH will increase from a 24% to a 34% for the 2019-2020 school year.

Reading: 8.5(F) make inferences and use evidence to support understanding

CSJH will increase from a 54% to a 59% for the 2019-2020 school year.

Science: 8.10B identify how global patterns of atmospheric movement influence local weather using weather maps that show high and low pressures and fronts.

CSJH will increase from a from a 13.53% to a 30%% for the 2019-2020 school year.

Social Studies: 8.4 History. The student understands significant political and economic issues of the revolutionary era.

CSJH will increase from a 36% to 46% for the 2019-2020 school year.

4.
